INTRODUCTION

This Privacy Notice ("**Privacy Notice**") describes the data that we collect about you on the website from which you linked ("**Site**"); how we use and disclose that data; how we protect it; and the choices you may make with respect to it. PERSONAL DATA

"Personal Data" is data that identifies you as an individual or relates to an identifiable individual including surname, name, patronymic, year, date of birth, nationality, information about the place of residence and (or) place of registration, individual identification number, identify documents (number) and other information. The processing of Personal Data in this Privacy Notice means collection of the above data, their systematization, accumulation, storage, clarification (update, change), use, blocking, destruction, cross-border transfer and depersonalization, if necessary.

DATA SECURITY

We seek to use reasonable organizational, technical and administrative measures to protect your Personal Data. Unfortunately, no data transmission or storage system can be guaranteed to be 100% secure.

RETENTION PERIOD

We will retain your Personal Data for as long as needed or permitted in light of the purpose(s) for which it was obtained and as outlined in this Privacy Notice. The criteria used to determine our retention periods include: (i) the length of time we have an ongoing relationship with you and provide the Site to you; (ii) whether there is a legal obligation to which we are subject; or (iii) whether retention is advisable in light of our legal position (such as in regard to the enforcement of the Site Terms of Use, applicable statutes of limitations, litigation or regulatory investigations).

CROSS-BORDER TRANSFER

The data we collect through the Site may be stored and processed in any country where we have facilities or in which we engage service providers, including in the U.S. and where our affiliates operate.
